The Council shall follow the order of citizens wishing to speak as listed on the agenda followed by the order on the sign-up sheet.

 The City Council is not permitted to respond to comments or questions from the public on items not listed on the Regular Agenda. Responses are limited to a statement of specific factual information, a recitation of existing policy or direction to staff to place the subject on the agenda for a future City Council meeting. The use of vulgar, profane, inflammatory, or defamatory language is not permitted. Speakers shall not maker personal, impertinent, profane or slanderous remarks.
