

RESOLUTION 050424

**A RESOLUTION CANVASSING THE RETURNS OF AN ELECTION OF TWO
(2) ALDERMAN, ONE (1) MAYOR, AND ONE (1) SPECIAL ELECTION HELD
ON MAY 4, 2024, IN THE CITY OF LORENZO GENERAL ELECTION.**

WHEREAS, the City Council of the City of Lorenzo, Texas, resolved and ordered that a General Election be held on May 4, 2024, for the purpose of electing one Alderman in Ward #1 and Mayor. Alderman in Ward #2 and Ward #4 are Uncontested Candidates Declared Elected.

WHEREAS, the returns of said election have been duly canvassed by the City Council, and there being cast at said election of a total of 155 votes, and each of the candidates in said election having received the following votes to wit:

IT IS, THEREFORE FOUND, DECLARED, AND ORDERED by the City Council of the City of Lorenzo that the above election was duly called. That notice of said election was duly posted and that said election was held in accordance with the laws of the Texas Election Code. That at said election Cheryl Birdwell was elected Alderman Ward #2; Rhonda Cypert was elected Alderman Ward #4 of the City of Lorenzo City Council; Lori Landin was elected Mayor of the City of Lorenzo; Earlene Rampy was elected Alderman Ward #1 of the City of Lorenzo City Council subject to taking the oath.

SECTION 1: That it is further found and determined that the results of the election as canvassed and tabulated in the preamble hereof reflect the expressed desires of those persons voting at said election.

IT IS FURTHER FOUND AND DETERMINED that in accordance with the laws of the Texas Election Code; the City Secretary posted written notice of the date, place and subject of this meeting on the bulletin board located at City Hall. A place convenient and readily accessible to the general public and said notice having been so posted and remaining posted continuously for at least 72 hours proceeding the scheduled time of said meeting. A copy of the returns of said posting shall be attached to the minutes of this meeting and shall be made as part hereof for all intents and purposes.


