# Official Minutes City Of Lorenzo, TX March 10, 2025

# PUBLIC HEARING & REGULAR MEETING CITY COUNCIL ROOM - LORENZO, TX 7:00 P.M.

Mayor Lori Landin called the Public Hearing to Order at 7:00 p.m. with the following Council Members present: Aldermen, Earlene Rampy, Cheryl Birdwell, Janet Peterson-Gonzales, Rhonda Cypert and Hilda Castillo. Also present were City Manager Michael Chambers, City Secretary Lisa Hernandez, Public Works Director Chad Mobbs, City Utility/Court Clerk Isabel Salazar, Crosby County Sheriff Corey Nunley, Crosby County Deputy Chief Frank Lara, County Deputy Monty Roberts, Fire Chief Josh King, Fire Assistant Chief Celeste Rackler, and guests.

Lorenzo City Council Member Rhonda Cypert gave the Invocation followed by the Pledge of Allegiance led by Mayor Pro-Tem Cheryl Birdwell.

### **Public Comment:**

Samantha Hyatt with TCG talked about code enforcement and with the cleaning that is being done at the properties on main street she strongly recommends to issue a 30–60-day abatement. She also speaks on the property at 6<sup>th</sup> street and that the family that have become the heirs do not want the property. She has tried several times contacting Eustacio Lozoya but has not had any luck and suggested a 30-day-abatement.

Lars Hegdahl speaks on his properties that are on main street and is not very happy with how things are being done to him. He is recommending on donating the deed of 504 Harrison to the City.

Councilmember Janet Peterson-Gonzales said "she spoke to Juan the owner of the restaurant and that he has concerns on his building not being safe when people park." She asks Lars what his plans are for the building and if he would sell to Juan for \$1.00. The City Mayor Lori Landin asked Lars what his plans were for the buildings. Lars answers by saying that there are several questions being thrown at him and says to Mayor Lori Landin if it affects the outcome with the abatement? Mayor Lori Landin said that it could affect the outcome. He then asks councilmember Janet Peterson-Gonzales for the record you want me to sell my property for \$1.00 to Juan? She responded that was not what she said Juan said that. He repeated that she had just said that and she responded that Juan was the one that recommended that. Lars then said that him and Juan had come to an agreement and the he was going to sell to Juan all three of his buildings for \$4,000 and he had agreed but then a certain councilmember spoke to Juan and then Juan did not want to purchase the buildings anymore.
